Both the marriage and divorce rates of U.S. women age 15 and older declined from 2011 to 2021. In 2021, the U.S. marriage rate was 14.9 marriages in the last year per 1,000 women, down from 16.3 a decade earlier. And the 2021 divorce rate dropped to 6.9 in the last year from 9.7 divorces per 1,000 women in 2011. Children whose parents have divorced are increasingly the victims of abuse. They exhibit more health, behavioral, and emotional problems, are involved more frequently in and drug abuse, and have higher rates of suicide. Children of divorced parents perform more poorly in reading, spelling, and math.

Who causes the divorce?

Whether accepted or not, there is one fact that cannot be disputed. And that is that women initiate divorce more often than men on average. Numerous studies have shown this. Nearly 70 percent of divorces are initiated by the wife. In addition, over 50% of divorced wives never want to remarry while only about 30% of men express that same sentiment. While it is established that about half of all marriages end in divorce, it is commonly assumed that the breakups are initiated by both genders equally. What is the divorce rate in the world?

Per the UN Yearbook, the divorce rate in 2021 was 1.8 using the available data on marriage and divorce worldwide. Many countries' data on the number of divorces for 2022 is pending, but based on the collected data for 56 countries, the average crude divorce rate in the world last year was about 1.6. The archipelagic paradise is world renowned for its tropical beaches and a diverse marine ecosystem, but seldom associated with divorce. Not only did the Maldives have the highest divorce rate in the world in 2021, but it also has the highest divorce rate of any country of time in history. Maldives tops the list with the highest divorce rate per 1,000 people, standing at 5.52, followed by Kazakhstan, Russia, Belgium, and Belarus. The United States comes in midway, with a divorce rate of 2.7 per 1,000 people, equaling countries such as Denmark, Lithuania, and Latvia. Divorce usually entails the canceling or reorganizing of the legal duties and responsibilities of marriage, thus dissolving the bonds of matrimony between a married couple under the rule of law of the particular country or state. It can be said to be a legal dissolution of a marriage by a court or other competent body.
